- C. SAAC Update Chesick
  - Provided a brief update on recent conference call with campus SAAC leaders. Informed group that PSAC would host the league SAAC meeting on March 22-23 in Lock Haven with the expectation that campus SAAC liaisons would attend this year for SAAC development programming.

Led a discussion about the conduct of the Conference's Championships formats and when divisions should "crossover" in conference tournament brackets. Costs, missed class time, quality of tournament all were brought up. A non-binding straw poll was taken indicating support for crossovers in the quarterfinal rounds. More discussion will occur with effected coaches groups at their upcoming meetings, the conference will look at past tournament brackets and more discussion will occur at the April 2019 meeting.

The new schedules for all sports were distributed and reviewed. Some clarifications were needed and addressed under sports specific items. A discussion developed regarding the determination of mandated dates of the week to play mid-week contests in outdoor field sports. It was discussed that Soccer wants only Wednesday dates and Field Hockey and Lacrosse preferred alternating dates.

There was a discussion about the future Athletic Training and institutional coverage at the PSAC Indoor Track Championships. It was determined that the conference would develop a rotation of programs but that those would not conflict with the Swimming Championship coverage.

3. Men's & Women's Tennis - Heitzman

#### 6. Volleyball – Hjerpe

There was a discussion held regarding the future format of scheduling in the sport of Volleyball. Whether the four divisional format was in the best as currently employed or if the conference should move to a two division format. Only the 2019 schedule was approved by the Championships Committee. The Volleyball Coaches will discuss the issue in more detail at their end of year annual meeting with further consideration by the Administrators at the April 2019 meeting.

- 7. Men's & Women's Basketball Traver & Grimm
- A) Management of Start Times for Crossover basketball games

A lengthy discussion was held regarding the formatting of start times in crossover contests, particularly those contests that occur just prior to the NCAA Mandatory Winter Break.

It was decided based on past precedent of conference mandated scheduling that:

Crossovers scheduled for Saturday/Sunday formats would start at 1:00 pm; while all other formats would be 5:30 pm starts.

B) Drawing of 'BYE' Teams for 2018-19 Schedule

Because of the imbalance in sports sponsorship for basketball with 17 members in the league in 2018-19, it was determined that one game from three Western Division team would be randomly drawn and designated as "non-counting" for those respective Western Division teams only.

Gary Gray lead a brief discussion regarding the potential of developing conference-wide policies regarding student-athletes with serious misconduct issues prior to enrollment.

A taskforce was established with Gray chairing it, including Karen Hjerpe, Lisa Goddard-McGuirk, Carrie Michaels and Todd Jay. The Taskforce will report back in April with potential legislation considerations

### C) Hot Weather Policies

Terry Beattie brought the issue regarding conference-wide policies on hot weather monitoring and athletic competition to the group. West Chester had encountered the issue in an out-of-conference contest. The Athletics Administrators directed the Conference office to work with the Athletic Trainers group to review the issue and recommend appropriate policies
