Pennsylvania State Athletic Conference CONSENT ITEMS 2019-20

Spring 2020 PSAC Legislative Cycle

ALL RECOMMENDATIONS CONSIDERED WERE DEEMED CONSENT ITEMS

1) To enter into an agreement with Roberta Butler to serve as PSAC Officiating Coordinator for Field Hockey through the 2024 Season (2024-25 academic year).

The Fee Structure will be:

Fall 2020: \$195/game (\$98/scrimmage) Fall 2021: \$200/game (\$100/scrimmage) Fall 2022: \$200/game (\$100/scrimmage) Fall 2023: \$205/game (\$103/scrimmage) Fall 2024: \$205/game (\$103/scrimmage)

Mileage: \$0.40/mile round trip through 2024 Scheduling Fee: \$350/program through 2024

2) To enter into an agreement with Roberta Butler to serve as PSAC Officiating Coordinator for Lacrosse through the 2025 Season (2024-25 academic year).

The Fee Structure will be:

Spring 2021: \$210/game (\$105/scrimmage) Spring 2022: \$215/game (\$108/scrimmage) Spring 2023: \$220/game (\$110/scrimmage) Spring 2024: \$225/game (\$113/scrimmage) Spring 2025: \$225/game (\$113/scrimmage)

Mileage: \$0.40/mile round trip through 2025 Scheduling Fee: \$350/program through 2025

- 3) That in the sport of volleyball, scoresheets must be emailed to all conference coaches at the same time the upload of match video is sent to the video exchange platform.
- 4) That in the sport of volleyball, the PSAC move to a two-division structure and double round-robin scheduling format within each division for the 2020 season.
- 5) For the sport of volleyball, the PSAC will conduct an 8-team conference tournament, with the top four teams from each division advancing to the quarterfinals. Quarterfinal matches will be conducted within the respective Divisions (4 at 1, 3 at 2). The semifinals and finals will be hosted by the highest remaining seed beginning with the Eastern Division in 2020.
- 6) In the sport of Football, to adopt the following tie-breaker criteria in the event of ties to determine which team participates in the conference championship game.
 - A) Head to Head results among tied teams
 - B) Record against teams in the division not involved in the tie starting at the top of the standings
 - C) Overall record in mandated conference games (divisional and crossovers included)
 - D) Mandated crossover opponents aggregate record in their division only games
 - E) Road wins among the 9 mandated games
 - F) Record vs. teams in the opposite division starting at the top of the standings
 - G) Coin Toss
- 7) In the sport of Women's Soccer, beginning in 2021, to contest the PSAC Tournament with the quarterfinals on Saturday, and semifinals the following weekend on Friday and Championship match on Sunday.

- 8) That in the sport of Soccer, following Daylight Savings Time, conference matches played on facilities without lights may not begin prior to 11:00 am and no later than 3:00 pm.
- 9) Effective 2019-2020, to not include the total aid financial aid data in the sports of football and men's and women's basketball when providing the PSAC Grant-In-Aid Equivalencies document to member institutions.
- 10) Effective 2020-2021, to include total rostered athletes (using the EADA methodology) and total number of athletes received athletic scholarships when providing the PSAC Grant-In-Aid Equivalencies to member institutions.
- 11) That in the sport of Softball, beginning with the 2021 season, the PSAC Softball regular season schedule be constructed in a two division format of 9 teams each, playing a single round robin of doubleheaders against each opponent in the respective Division. Additionally, 5 teams from each Division will qualify for the championship tournament to be conducted in a 10-team double-elimination format.
- 12) That the PSAC enter into an agreement to conduct the PSAC Championship Softball Tournament in Quakertown, PA with Richmond Area Softball Association as host through 2024.

Fall 2019 PSAC Legislative Cycle

ALL RECOMMENDATIONS CONSIDERED WERE DEEMED CONSENT ITEMS

- 1). In the sport of baseball, to set the start time for single 9 inning games in the Eastern Division at 2 PM
- 2). In the sport of baseball, to set the start time for doubleheaders in the Eastern Division at noon
- 3). In the sport of baseball, to conduct the PSAC Tournament in the following format: Single elimination first round games, double elimination for the remainder of the tournament all at the same site starting with the 2020 Championship
- 4). To eliminate the 4x800m relay from the PSAC Indoor Track and Field Championships with an effective date of 2021.
- 5). To eliminate the 4x800m relay from the PSAC Outdoor Track and Field Championships with an effective date of 2021.
- 6). Declarations for the PSAC Indoor and Outdoor Track and Field Championships shall extend beyond the qualifying list so that the games committee is able to fill the field to the size identified in the sport operating code.
- 7). In the Sport of Tennis, for PSAC Championship quarterfinal matches, the host institution shall have 6 courts in the same location available for use (so all 6 singles can start at the same time). Additionally, if weather necessitates moving the match indoors, a minimum of 3 courts shall be available.
